INDEX DESCRIPTION

Prague Stock Exchange Index (PX)* is a free float weighted price index made up of the most liquid stocks traded on Prague Stock Exchange. The index is calculated in CZK and disseminated in real time.

PX is designed as a tradable index to be used as an underlying instrument for structured products and for standardized derivatives (futures & options).

Constituent weights are capped on a quarterly basis to ensure compliance with UCITS IV standards for portfolio diversification.

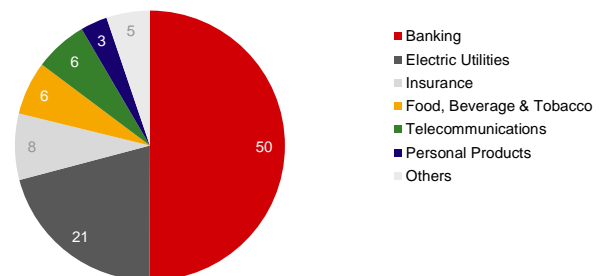
