INDEX DESCRIPTION

PX-GLOB* has been designed as an all-share index of the Czech stock market and is made up of all stocks traded on the regulated market of Prague Stock Exchange. The index is a market-cap weighted price index and is calculated in CZK and disseminated once a day after the closing of the trading session.

PX-GLOB is designed as a tradable index to be used as an underlying instrument for structured products and for standardized derivatives (futures & options).

Constituent weights are capped on a quarterly basis to ensure compliance with UCITS IV standards for portfolio diversification.

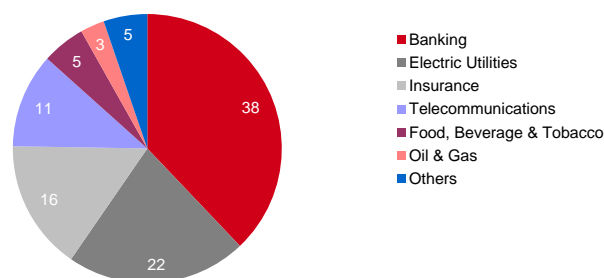
